### 1. Product description

KEIM 1&F-Grund is a colourless, solvent-containing primer with very good water vapour permeability.

## 2. Field of application

KEIM I&F-Grund is used to consolidate very difficult substrates. Typical application fields are slightly chalking substrates or substrates susceptible to staining.

## 3. Product properties

### 4. Application instructions

With KEIM I&F-Grund difficult substrates can be treated according to the extent of damage.

A one-coat application might be sufficient. In general it is recommended to apply two coats with a waiting time of at least 5 hours in between. KEIM I&F-Grund is delivered in a ready-to-use consistency and has to be applied undiluted. The substrate must be sound, dry and dust-free. After at least 5 hours drying time it can be overcoated with the KEIM Biosil-, Ecosil-ME-, Quarzil-, Concretal-, Soldalit- or Granital-System.

### **Application conditions**

Ambient and substrate temperature at least +5°C.

#### Consumption

Two-coat application: approx. 0.2 l/m<sup>2</sup>.

#### Cleaning of tools

Clean with nitro thinner immediately after use.

### 6. Storage

Shelf life is approx. 12 months if tightly sealed under cool, but frost-free conditions. Store at a well-ventilated place, protect from heat and direct sunlight, keep away from ignition sources.
